The NSF Nonfood Compounds Registration Program is a continuation of the USDA product approval and listing program, which is based on meeting regulatory requirements for appropriate use, ingredient review and labeling verification.

**This product is acceptable as a degreaser or carbon remover for food cooking or smoking equipment, utensils, or other associated surfaces (A8) in and around food processing areas, where its use is not intended for direct food contact. Use of this product in food processing or handling facilities requires that all food products and packaging materials be removed or protected prior to product use. A potable water rinse of cleaned surfaces is required after use of this product. When used according to manufacturer's instructions, the cleaner shall neither exhibit a noticeable odor nor leave a visible residue.**

**This product is acceptable as a laundry product for fabrics not contacting food (B2). This product may be used on uniforms or other fabrics that do not come in direct contact with food products.**

**This product is acceptable for use in inedible product processing areas, nonprocessing areas, and/or exterior areas of food processing establishments (C1) provided that it is not used to mask odors resulting from unsanitary conditions, and that any characteristic odor or fragrance does not penetrate into an edible product area. When used on equipment that will be returned to a food processing area, the product must be completely washed off and rinsed with potable water before returning to the processing area.**

NSF Registration of this product is current when the NSF Registration Number, Category Code, and Registration Mark appear on the NSF-approved product label, *and* the registered product name is included in the current NSF White Book Listing of Nonfood Compounds at the NSF website (<http://www.nsf.org/usda>).
